Terms:

I have selected the services checked on the front of this agreement form and it has been explained to me to my satisfaction and understanding.

By signing this agreement, I have agreed to contract Perfekt Photo to photograph my wedding as outlined on the front of this agreement form.

Perfekt Photo will be the exclusive photographer for my wedding. No other professional photographers will be contracted to photograph my wedding. Professional videographers, and family with video / still cameras will be allowed to record my wedding. However, I will inform them that Perfekt Photo will be our primary image maker. Anyone who will be taking a significant amount of photographs or video coverage will need to check in with David Murphey before the start of the wedding ceremony.

To book my date, I understand a \$ 500.00 deposit toward the final price is required. Perfekt Photo agrees to reserve the time and date on the front of this agreement form and will not make other reservations for that time / day. For this reason, my deposit is nonrefundable in the event of cancellation. If my wedding date is changed, Perfekt Photo will transfer my deposit for that date upon availability. If that date has been booked, I may choose another date or forfeit my deposit.

The balance of my account is due 2 weeks prior to my wedding day.

My online web gallery and DVD will be available to me approximately 4 weeks after my wedding day.

Albums will be ready 4 months after selections has been made.

Album design process. After I have received my proofs, I will select the photographs to go into my wedding album. The number of selections is determined by the package I have selected on the front of this agreement form. Perfekt Photo will design my album and e-mail me a web proof of the album layout before it is printed. It is my responsibility to check the proof to make sure the correct photographs are included in the album. I may request design changes to the layout. However, making revisions to the original layout is not included in the original album / package cost and will be billed at \$75.00 an hour.

Wedding photography services are hourly based. This includes travel time between photography locations. You may choose not to use all of the hours allowed. However, hours are not transferable to another day or service.

Travel Fees. Turtle Bay and the north shore areas of Oahu - \$200.00. Maui, Kauai and the Big Island - \$800.00. West Coast States - \$2000.00. Fees cover all travel expenses, including airfare, hotel, rental cars and meals for the photographer and his assistant.

Wedding photography packages include credit towards albums, portfolios and additional photography services. Credits are not transferable and expire 1 year after the date of your wedding.

For services over 5 hours, the photographer and his assistant will be provided a meal during the reception. The couple understands that the photographer should be seated with a clear view of the bride and groom to facilitate their reception coverage.

Table photographs of guests during the reception are not included with the photography service.

My photographer will arrive 5 minutes before the scheduled start time, and leave exactly at the specified end time on the front of this agreement form. My photographer is not responsible for scheduling difficulties beyond his control. (Example: Your makeup person arrives late and sets back the wedding schedule by an hour. The photography end time will still be the same.) If requested, your photographer will work in overtime to complete the photography of your wedding day. Overtime will be billed at 300.00 an hour. Overtime is billed to the next complete hour.

Photograph usage and reproduction rights. Perfekt Photo will retain full copyrights of all images photographed. Photos may be used by Perfekt Photo for advertising, display and promotional purposes. I am allowed to make reprints for personal use. This includes display at home, work, personal website and as gifts for family and friends. I am not allowed to sell or to publish commercially any photographs in any media (traditional print or electronic) without written consent by Perfekt Photo.

Although great care will be taken with the original photographs taken of my wedding, unforeseen occurrences may occur (i.e. loss or damage). In this event, Perfekt Photo will do everything in their power to rectify the situation in a reasonable manner.
